As of 31 January 2026, *Sriwijaya Law Review* (SLRev) marks its tenth year of publication. A decade represents a significant milestone in sustaining a scholarly journal, reflecting continued commitment to academic rigor and intellectual contribution. This achievement coincides with the publication of Volume 10 Issue 1 (January 2026), which signifies both continuity and growth in the journal's scholarly mission.

In this issue, SLRev publishes ten peer-reviewed articles authored by scholars from across Asia, Australia, and Europe, highlighting the journal's expanding international reach. The articles address a diverse range of legal issues, encompassing both national and international perspectives.
